Subject: Reply to a request for additional information or clarification regarding the preparation of the bid

At the request of an interested party for the additional information or clarification regarding the preparation of bids in an open public procurement procedure whose object are goods, "**Reconstruction of Boiler Room "ZASTAVA" with the purpose of replacing a part of the capacity of coal-fired boilers with the combined natural gas-powered and heavy fuel oil-powered boilers, Phase I**" - number of the public procurement **1.1.47 / 2017**, Purchaser in accordance with Article 63 of the PPL, publishes answer.

Questions:

1. Considering the public procurement number 1.1.47/2017 "Reconstruction of Boiler Room "ZASTAVA" with the purpose of replacing a part of the capacity of coal-fired boilers with the combined natural gas-powered and heavy fuel oil-powered boilers, Phase I", and in accordance with the provisions of Article 63, paragraph 2. Law on Public Procurement, please provide additional information and clarification of the public procurement. Namely, considering the fact that you modify the bidding documents on December 11, 2017 – Changes and additions to the tender documentation 2, and on this occasion there was a slight shift in Forms 13, 14 and 15, relating to certificates of buyers of goods, our question is:

- Will the Certificates of customers that are already collected based on an earlier version of the tender documentation be accepted?

We are asking the Purchaser to accept them since the changes are minimal textually, and a new acquisition requires additional time, since some are collected from abroad and even impose additional costs for bidders.

Answers:

Since the Purchaser change the respective patterns in the "Remarks" where he added just one sentence and that sentence is "the number of sold and delivered _____ must correspond with the number of _____ in the form reference list" and that the article in question does not affect the actual content and form of the form confirming customer, the Purchaser will accept forms that do not contain the given text. Of course, until the number of units sold and delivered goods correspond with the appropriate reference list.

So, once again, given sentence is only a guideline to bidders in order for the Purchaser to draw attention that the number of sold and delivered goods must be matched with the corresponding reference list and does not affect the very form and content of the confirmation of the customer and will be accepted by the Purchaser if buyers of goods already to the bidders filled out the form mentioning confirmation of the buyer, and whose re-filling represent a huge burden for suppliers in the form of additional time and resources.
