## TO POTENTIAL BIDDERS

SUBJECT: Changes and additions to the tender documentation

Pursuant to Article 63. Paragraph 2 of the Law on Public Procurement, we are publishing the changes and additions to tender documentation <u>in open procedure</u> of the public procurement: **Reconstruction** of Boiler Room "ZASTAVA" with the purpose of replacing a part of the capacity of coal-fired boilers with the combined natural gas-powered and heavy fuel oil-powered boilers - Phase I, no. 1.1.47 / 2017

The tender documentation changes as follows:

- On the Page 12 under "REMARK" the "using the gas fuel" is added;
- On the Page 16 instead of standard EN 954-1 the standard EN 3849-1 is added, under the "REMARK" the "using the gas fuel" is added and the description of paragraph 3 is changed under "electrical command cabinet";
- On the Page 23 under "stack system" the description of "characteristics" has been changed;
- On the Page 30 the description under "Documentation which the Bidder shall submit with the bid" is changing;
- On the Page 36 deleting the point 1 of evidence "A" for technical capacity;
- On the Page 37 totally deleting the human resources capacity, while the business-financial capacity is changed in point 3 of the evidence;
- On the Page 42 the description under "Mandatory content of bid" is changing;
- On the Pages 44 and 45 the description under point 11 has been changed Price, as well as the description under point 12 financial security;
- On the Page 51 the description of first paragraph is changed in point 19 of Instruction to bidders how to make a bid;
- On the Page 55 the point 2 of the bid form has been changed;
- On the Pages 80, 81, 82 and 83 Statement on human resources capacity has been deleted;
- On the Page 91 Promissory note for seriousness of bid form has been changed;
- On the Page 93 Promissory note model for refund of advance payment has been changed;
- On the Page 95 Promissory note model for elimination of defect during the warranty period has been changed;
- On the Page 103 the first paragraph of the Article 3 and second paragraph of the Article 4 of the Framework Agreement Model has been changed;
- On the Page 104 the third point of the article 6 of the Framework Agreement has been deleted;
- On the Page 106 the first and the second paragraph are deleted and the 4 paragraph of the Article 9 of the Framework Agreement has been changed;

- On the Page 107 the paragraph 7 has been changed, while the paragraph 8 has been deleted within the Article 9 of the Framework Agreement Model;
- On the Page 110 the point 6 of the second paragraph of the Article 16 of the Framework Agreement Model has been deleted;
- On the Page 113 the first paragraph of the Article 3 of the Contract Model has been changed;
- On the Page 113 the Article 4 of the Contract Model has been changed;
- On the Page 114 the point 3 of the Article 6 of the Contract Model has been deleted;
- On the Page 117 the paragraphs 6 and 7 of the Article 9 of the Contract Model has been deleted;
- On the Page 120 point 6 of the second paragraph of the Article 16 of the Contract Model has been deleted.

<u>Bidders must adjust their offers to the specified changes in the tender documentation. Since the tender documentation has been changed in accordance to the Decision of the Republic Commission for protection of rights in public procurement procedures, the deadline for submission and opening of bids will be extended to May 7th, 2018 10:00 am untill 10:30 am.</u>
